Our employees sign their employment agreements in Romania

- How much do your employees who work for TEE earn per month? Is a reimbursement for costs included in this amount? Can you give us a precise composition of the wage of your employees?

The basic salary for our employees who work at TEE is 2800 euro, plus additional expenses.

- Where are your trucks refueled and how is this funded? Do drivers use your company's fuel cards?

We work with AS24 and can refuel in any country of Europe but the trucks are refueled mainly in Belgium and France

- Where does the reading of the digital driver cards take place?

The reading of the digital driver cards takes place remotely via a USB Smart Card Reader.

- What happens with the cmr's? How are these delivered to the employer?

The CMR's are brought in the original by our drivers and passed to TEE dispatch team every time the trucks come to TEE (Erpe Mere)

- Where are the trucks maintained?

The trucks are maintained at licensed truck shops and truck services in Europe

- How often do the trucks go back to the country of residence of your company?

The trucks come back to the country of residence by possibility. At the moment we do not have an established schedule

When the drivers have their vacation the truck is parked at TEE private parking
