Declare on honor being fully aware of my obligations as carrier, that is:

- 1. to respect all national and European Union regulations applicable to companies exercising the activity of public road transport of goods, and specifically:
- For the access to the road haulage profession: to meet all the conditions to be complied with to pursue the occupation of road transport operator and to have all the permits and licences necessary to be engaged in such occupation, including a Community licence, a certified true copy of which shall be carried on board the vehicle,
- For posting of workers: to send, before loading, a posting certificate ("Loi Macron") of each driver posted into the French territory, a copy of which shall be carried on board the vehicle,
- For compliance with the social regulations in road transport:
- o to send, before loading, a social security certificate (A1) of each driver posted into the French territory, a copy of which shall be carried on board the vehicle,
- to respect driving time and rest periods (including the prohibition of weekly rest period in the cab and the requirement for drivers to return to their place of residence or to the Member State where their employer is established in any four-weeks period of consecutive work),
- o to respect the minimum wage laws.
 - 2. to respect the rules on cabotage, that is:
- > to transmit, before loading, the number plate of the vehicle to be indicated on the consignment note, the top copy of which shall be carried on board the vehicle
- > to respect the following conditions:
- o for an international transport to French territory as a final destination: after complete unloading of the international freight in France, not carrying out more than 3 cabotage operations on French territory and achieving it within 7 days from complete unloading of the international freight in France;
- o for an international transport to another territory as a final destination: after complete unloading of the international freight in another territory, not carrying out more than 1 cabotage operation on French territory, within the 3 days following the entry of the empty vehicle into France, and achieving it within 7 days from complete unloading of the international freight;
- from February 21, 2022: respecting the cooling-off period of 4 days (before carrying out any new cabotage operation on French territory with the same vehicle).
 - 3. to request Geodis written authorization prior to subcontracting any transport service entrusted by Geodis.
 - 4. in the case of sub-contracting authorized by Geodis, to ensure that the obligations mentioned in paragraph 1 and 2 are respected by my own subcontractors.

And pledge to respect these obligations for the entire term of the contractual relationship with Geodis and to renew the present declaration every year.
